## HONORARY MAYOR OF EAST HILLSBOROUGH RACE

The Valrico FishHawk Chamber of Commerce Honorary Mayor's Race recognizes caring citizens in the East Hillsborough community. Candidates utilize their time, talent, and fundraising capabilities to raise money benefiting the East Hillsborough area 501(c)(3) charities.

The Honorary Mayor of East Hillsborough represents the Valrico FishHawk Chamber of Commerce at East Hillsborough community area functions.

### **GENERAL**

- The Honorary Mayor of East Hillsborough Race shall begin June 1<sup>st</sup> and end June 30<sup>th</sup>.
- Geographic area is East Hillsborough County defined as east of 301 and south of I-4.

### APPLICANT/CANDIDATE

- Applications will be reviewed by the Valrico FishHawk Chamber of Commerce Board of Directors.
- Candidates must be at least 21 years of age.
- Candidates must live, work, or volunteer in East Hillsborough.
- Candidates are required to uphold the appropriate conduct and demeanor benefiting the office they aspire to, both in their personal behavior and campaign activities.
- Candidates and campaign managers are required to meet with the Mayor's Race Board Chair prior to the April General Assembly.
- Candidates not receiving the Mayoral title may reapply to run for the Honorary Mayor of East Hillsborough position in subsequent years.

### APPLICATION/ APPLICATION FEE

- Each candidate shall submit their application on the Valrico FishHawk Chamber of Commerce website by March 1<sup>st</sup> (90 days from the start of the race).
- Approval shall be no later than April 1<sup>st</sup> (60 days prior to the race).
- All candidates will be informed on the same day of the approval status.
- Each candidate shall pay a non-refundable application fee of \$50 online at valricofishhawk.org.
- A background check is required for all applicants.
- The Valrico FishHawk Chamber of Commerce reserves the right to reject any application.

### **MONEY TABULATION**

• Mayoral candidates will present all funds raised in the form of a CASHIERS CHECK(S) to the VFCC Mayor's Race Board Chair & one member of the chamber's Executive

- Committee preferably the Treasurer at 8:15am on the morning of the July General Assembly (the 2<sup>nd</sup> Tuesday of July). CASHIERS CHECKS ARE MADE PAYABLE TO THE VALRICO FISHHAWK CHAMBER OF COMMERCE.
- Checks will be available to all benefiting charities within 15 days of the presentation.

### TERMS OF OFFICE/SUCCESSION

- The Honorary Mayor shall take office upon being named and shall serve a term of one (1) year.
- Once named as Mayor, that person will not be eligible to run for the position again. The incumbent mayor is prohibited from serving on any committee supporting candidates in the next mayor's race.
- VFCC Board Members are invited to support candidates. The Chairman of the Board, President, and the Mayor's Race Board Chair are excluded from serving on a campaign committee unless they are an active board member or volunteer of one of the benefiting charities. In the event of an uncontested race, this provision will be waived.
- The Honorary Mayor will represent and support the Valrico FishHawk Chamber's events, including Ribbon Cuttings, the Annual Dinner, Shop Local, the Back to School Luncheon, Networking meetings, and Fundraising events. (Minimum of 1 special event per month)
- The Honorary Mayor will represent the Valrico FishHawk Chamber of Commerce at East Hillsborough community area functions i.e. rotary meetings, hospital functions, etc.

### SPONSORING ORGANIZATION

- The candidate will determine the sponsoring organization that will process and manage funds throughout the campaign. The sponsoring organization is responsible for processing and managing all funds throughout the campaign.
- The sponsoring organization must be one (1) of the benefiting charities.
- The candidate may designate only one (1) sponsoring organization.
- The Certificate of Insurance should be available from the sponsoring charity as requested by event venues.

# **DESIGNATED CHARITY(IES)**

- The candidate may designate up to 3 benefitting charities within East Hillsborough area.
- All charities must be registered and current 501 (c)(3) organizations. Charities are not required to be members of the Valrico FishHawk Chamber of Commerce.
- Candidates will establish Memorandums of Understanding (MOUs) with benefiting charities detailing the expectations of participation. Percentages will be determined at the end of the race at the discretion of the candidate based on the involvement of the benefiting charities.

• Candidates will submit Memorandums of Understanding (MOUs) to Valrico FishHawk Chamber of Commerce Mayor's Race Board Chair prior to the start of the race no later than May 1<sup>st</sup>.

### DISBURSEMENT OF MONEY RAISED

• Monies submitted to the Valrico FishHawk Chamber of Commerce for tabulation in connection with the Mayor's Race shall be disbursed as follows:

Seventy-five Percent (75%) Designated Charity(ies) based on MOUs

Fifteen Percent (15%) Sponsoring Organization

Ten Percent (10%) Valrico FishHawk Chamber of Commerce

### **FUNDRAISING**

- Submit all fundraising activities and/or events to Valrico FishHawk Chamber of Commerce Mayor's Race Board Chair for approval prior to marketing or promoting the events. The Valrico FishHawk Chamber of Commerce Mayor's Race Board Chair will approve all events within 48 hours.
- All events or activities, either virtual or in person, are to run from June 1st -30th.
- Candidates may schedule up to four (4) ticketed in person events and a kick-off event.
- Sponsorships and donations for raffle and silent auction items may be collected starting May 1<sup>st</sup> (31 days prior to the start of the race). Sponsorship names and amounts collected prior to the start of the race need to be submitted to the board chair.
- Event ticket sales may begin May 25<sup>th</sup> (7 days prior to the start of the race).

### **MARKETING**

- Each candidate will coordinate with their marketing committee member to produce promotional materials.
- Determine sponsorship levels for marketing materials.
- Social media pages may be created on May 1st.
- Promote the race through the Osprey Observer. The deadline for submission is April 10<sup>th</sup>. An editorial will be published in all May editions, and a complimentary ad will be available if the candidate chooses.
